3. Most of the departments of the college have their own computing facility with internet connection. College has a separate computer lab. Most of the offices of the college are also having computing facility
4. To encourage the teachers for the purpose of encouraging research activities college administration on the recommendation of IQAC has made a provision to reimburse the registration fee and TA/DA to the teachers from autonomous funds for presenting their papers in seminar and conferences at national level. 7.1.7 – Initiatives taken by the institution to make the campus eco-friendly (at least five)

(1) PEDESTRIAN FRIENDLY PATHWAYS Vehicle parking space is provided at the main entrance of the college campus. As the campus is vehicle free with some exceptions, students and staff experience comfort walking through the pedestrian friendly pathways. The internal roads are lined with trees and solar lights and they are properly maintained by the campus maintenance committee.

(2) RESTRICTED ENTRY OF AUTOMOBILES The institute encourages the staff and students to use the transport instead of their own vehicles for safety,

security, fuel conservation and to reduce environmental pollution. The college buses are checked for pollution by the authorized agency. The vehicles owned by faculty or students with pollution check stickers are permitted into the campus. Random checks are made to check the validation and periodicity of this certificate. For two wheelers or four wheelers, security measures are mandatory. (3) BAN ON USE OF PLASTIC Single-use plastic items such as plastic bottles, bags, spoons, straws and cups are banned completely and awareness is created among staff and students through orientation and display boards in the premises. The staff and students are informed to use steel or copper water bottles instead of plastic bottles. To restrict the use of plastic, measures have been taken to replace plastic tea cups and glasses with steel glasses in the Department. (4) LANDSCAPING WITH TREES AND PLANTS Landscaping of the college is worth seeing and reflects aesthetic sense. The institute has a canopy of trees and plants to make the environment pollution free to safeguard the health of all the inmates. The lawns and the trees provide shade and beautiful ambience. Utmost care is taken to develop and maintain green landscaping by gardeners. The construction, maintenance and beautification committee constituted in the college looks after the development and maintenance of the greenery in the campus. The Context In this context some challenges are there which are to be faced by the institution viz. (i) Rural Background of the students (ii) Less understanding of the students in English etc. but college is trying its level best to meet those challenges and to cater the needs of the students of this semi-urban area- Bundelkhand region. 4. The Practice Being Govt. College, we have a limitation to follow the syllabus as designed by the central board of studies, department of higher education Bhopal. This is an autonomous college also therefore, as per UGC guidelines the college has a freedom to alter 20 of the curricula depending upon the requirements of local needs. The college is trying its level best to cater the needs of the students (i) by overcoming the challenges mentioned above through remedial classes (ii) by arranging and providing notes for the students related to the curriculum. College is doing this practice following the norms and regulations as laid by the UGC and state Govt. 5. Evidence of Success This practice definitely provide a better learning environment for the students pursuing their studies in the College. as evident from the success rate of the students in different courses is very appreciable every year. 6. Problems Encountered and Resources Required Staff of the college is firm to give its best to the students so far as basic work i.e. teaching and learning is concerned. Therefore, college is marching ahead in the direction of progress, whether (i) it is the matter of opening new courses, (ii) development of infrastructure (iii) arranging extra and remedial classes (iv) uploading the lectures on the website (v) arranging online classes or any other related matter. College under the able leadership of learned and qualified Principal sir, is facing the challenges to encounter the problems following the rules and regulations as laid down by the state Govt. and UGC. 7. 2. Objectives of the Practice The College is willing to be a rising star in the field of research also in this semi-urban region of Bundelkhand to cater the needs of the students in research who have to be dependent on nearby areas like Jhansi/ Gwalior to fulfill their needs for doing research and we are trying to scale the heights in this context also. 3. The Context College is the only premier institution in this region. It provides and fulfills the needs of students in different subjects with post-graduation in facilities in 12 subjects, out of which only 03 subjects viz. Hindi, Economics and Sanskrit were the recognized research centers of the affiliating university till last inspection of NAAC (IIInd Cycle). Now, we have 04 recognized research centres viz. Hindi, Economics, Sanskrit and Chemistry. We wish to develop some more new research centers to cater the needs of the students as it is the second largest college in Gwalior Chambal division of M.P. so far as student's strength is concern. We are also interested to provide a plate-form to research workers for the publication of their work. 4. The Practice The faculty of the College has tried a lot in this regard to fulfill this best practice as it is evident from the no of research papers by the learned faculty of the college. On an average ~7 -8 research papers are there per faculty member in our college. A few faculty members have a total of high impact factor of their published research papers in referred peer reviewed journals. Some of the faculty members are also enjoying as resource persons in different seminars/ conferences etc. Some of the faculty members have also participated in international seminars/ conferences. Names of some of the faculty members are also included in international databases such as SCOPUS etc. with appreciable impact factor/ citations/h-index/ i-10 index etc. A few Faculty members are also the members of editorial boards of different journals. All these faculty members are recognized guides/ supervisors in their respective fields/ subjects and we are also trying to increase this number, in order to achieve the objectives mentioned above. Four departments of the college are recognized research centers of the affiliating university as mentioned above in the section "Context" and two more have applied for it. This is again a cumulative effort of the faculty to achieve the objective mentioned above. College is also publishing its own multi-faculty research journal viz. "Research Spectrum" almost regularly which is having ISSN number. This is a step ahead in comparison to the previous NAAC inspection (IIInd cycle). We have a plan to make it a journal with valid and appreciable impact factor which would be included in the UGC -Care list. All these efforts by the learned faculty of the college may be included as the best practice in this regard. 5. Evidence of Success A lot of contribution by the learned faculty of the college in various aspects viz. publishing research papers, participating in seminars and conferences, completing their research projects, their research in collaborative manner with other organizations/ institutes, their contribution in editorial boards of various research journal and other related works done by them is the evidence of the success of the faculty to meet with this best practice.
